The Tech Sector, Especially SaaS, Continues To Be A Hot Market As The Shift To The Cloud Accelerates

As consumers change their behavior in response to COVID-19, the technology industry will see an increase in demand as company executives begin to prioritize technology and digital offerings

Economic Outlook

While the pandemic hurt the broader economy, the technology sector has been less impacted, as consumers and businesses have looked for technological advancements to support new ways of working and living

Tech dealmakers appear to have increasing levels of optimism, which could lead to record-breaking activity in 2021

Industry Activity




Deal value started 2020 with the lowest it has been since 2016, as companies reduced or eliminated many forms of spending in response to the pandemic




