



# A strong 2021 is expected for the staffing sector as vaccine rollout helps to stabilize regulation and work security for various industries across the world

With states beginning to see an increase in public activity, temporary and permanent staffing agencies are beginning to deploy staff and hit the ground running

## Staffing Market Outlook

- Overall, 2020 was a rough year for staffing; however, recent projections show that the US temporary staffing industry will grow by 11% in 2021 compared to an 8% decline in 2020
- 2021 projections are improving analysts expect direct hire placements to rise by 15% annually throughout the rest of 2021
- Key revenue drivers for the staffing industry in 2021 include the downward trend in the spread of COVID-19, a slow but steady recovery for GDP and more people leaving home after vaccination
- Healthcare staffing remains hot: the travel nursing industry rose 100% year over year in February

Q1 M&A activity among staffing services is up with 30 transactions for the quarter compared to 28 in Q4. Bridgepoint expects activity to increase with vaccine rollout


