IT Services Market Outlook

- **Transactions involving SAP integrators and** • service providers are up 5x from last quarter, showing a sharp rise in the opportunities presented by the software
- System integration multiples are nearly 2.5x above their historical average, evidence that the popularity of IT companies is still present as the pandemic begins to fade away
- Enterprises continue to embrace digital through 2021 despite the vaccine rollout; tailwinds suggest IT industry will continue to thrive
- The industry is ripe for a strong recovery as companies look to recover from the COVID-19 crisis and boldly position themselves to thrive in the future

Private equity and private equity-backed companies continue to deploy capital into the space and represent 64% of the deals done this year








